INSURANCE BENEFIT RENEWALS - GALLAGHER

Health, Dental & Life Insurance Renewal. Kristy Arciszewski with Gallagher showed a power point presentation of the savings Gallagher has negotiated for the city employees. United Healthcare's renewal was negotiated to a 0% increase with no change to coverage. Dental, life, vision and disability coverage would change to The Standard and all show significant savings to the employee. Alderman Larry Corder moved and Alderman Roger Romaker seconded the motion to approve the recommendation from Gallaher and approve the renewal of United Healthcare and implement The Standard for the remaining coverages for dental, vision, disability and life insurance renewal.
