**AN ORDINANCE SUSPENDING THE NATIONAL POLLUTANT
DISCHARGE ELIMINATION SYSTEM (NPDES) AN ORDINANCE
AMENDING CHAPTER 1150 ENTITLED "LIQUOR CODE,"
SECTION 1150-5 A. AND SECTION 1150-5 I.**

NOW, THEREFORE, be it ordained by the President of the Board of Trustees of the Village of Warrensburg, Illinois:

Section 1: That Chapter 1150 entitled "Liquor Code," Section 1150-5 A. be and the same is amended by deleting the existing language of subparagraph (A) and inserting the following language to read as follows:

A. No person who does not reside within thirty (30) miles of the Village limits;

Section 2: That Section 1150-5 I. Is amended by deleting the existing language of subparagraph (I) in its entirety and substituting the following:

(I) A corporation or limited liability company, if any member, officer, manager or director thereof, or any stockholder or stockholders owning in the aggregate more than 5% of the stock of such corporation, would not be eligible to receive a license hereunder for any reason other than citizenship and residence within thirty (30) miles of the Village limits;

Section 3: That this Ordinance, after passage and approval, shall be published in pamphlet form and shall be in full force and effect on October 3, 2022, after such publication, in the manner, form and time as provided by the Laws of the State of Illinois.






