ORDINANCE NO. 790

**AN ORDINANCE AMENDING SECTION 531-8, ENTITLED
“TERMINATION PROCEDURE FOR NONPAYMENT OF BILL”
PARAGRAPHS A AND B, AND SECTION 531-9, ENTITLED
“REINSTATEMENT OF SERVICE” PARAGRAPH A(1)
OF THE VILLAGE CODE OF WARRENSBURG**

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND
BOARD OF TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:**

SECTION 1: That Section 531-8 entitled “Termination Procedure for Non-payment of Bill”, paragraph A., be amended by deleting paragraph A. in its entirety, and substituting in its place the following language, to read as follows:

A. In the event the charges for service are not fully paid by the 15th of the month payment is due, a late fee of 20% of the outstanding bill shall be added.

SECTION 2: That Section 531-8 entitled “Termination Procedure for Non-payment of Bill”, paragraph B., be and the same is amended by deleting the first sentence of the paragraph and substituting in its place the following language, to read as follows:

B. In the event the original bill and late fee are not fully paid by the 25th day of the month, a reminder/termination notice, in the form of a hand tag or “door hanger,” shall be attached to the front or rear door of the premises.

SECTION 3: That Section 531-8 entitled “Termination Procedure for Non-payment of Bill”, paragraph B. (2)(a) be and the same is amended by deleting the existing language of subparagraph (a) and substituting in its place the following language, to read as follows:

(a) Payment of full delinquent charges, including original bill and 20% late fee.

SECTION 4: That Section 531-9 entitled “Reinstatement of Service”, A.(1) be and the same is amended by deleting the existing language of sub-paragraph (1) and substituting in its place the following language, to read as follows:

(1) Payment of the full amount of the original bill and the 20% late fee;
and

SECTION 5: That this Ordinance, after passage and approval, shall be published in pamphlet form and shall be in full force and effect on September 1, 2023, after said publication in the manner, form, and time as provided by the laws of the State of Illinois.






CERTIFICATE
