

Town of Watertown

The Traffic Rules and Orders Issued by the Manager under the authority of Section 22 and 22A of Chapter 40 of the General Laws, and Section 7 of Chapter XI of the Watertown Ordinances. Adopted May 7, 1991, with Amendments to June, 2020.

1. SCHEDULE I – PARKING

Add to Schedule I of the Traffic Rules and Orders North Beacon Street, south side, from North Beacon Court to a point '55 east of North Beacon Court; No Parking.

Add to Schedule I of the Traffic Rules and Orders Carroll Street, east side, from #9 Carroll Street to Carlton Terrace; No Parking.

2. SCHEDULE 1-A – PARKING METER ZONES SECTION 2: Off Street Parking Meter Zones

3. SCHEDULE IV – ISOLATED STOP SIGNS

Add to Schedule IV of the Traffic Rules and Orders Grant Avenue, for eastbound and westbound traffic at Piermont Street.

Add to Schedule IV of the Traffic Rules and Orders Katherine Road, for eastbound traffic at Common Street.

4. ARTICLE V – STOPPING, STANDING AND PARKING SECTION 6-A: Parking Meter Locations and Regulations

Subsection a)

<u>Remove</u>, "No person shall park a vehicle for a period of time longer than two hours between the hours of 7 A.M. and 6 P.M. on any on-street parking area".

<u>Replace</u> with "No person shall park a vehicle for a period of time longer than four hours between the hours of 8 A.M. and 8 P.M. on any on-street parking area except the Nichols Avenue Nichols Avenue on-street diagonal parking area".

Subsection e)

<u>Remove</u>, "The fee for parking in on-street parking meter zones shall be at the rate of fifty (50) cents per hour or ten (10) cents for each twelve (12) minute period up to the maximum limit which is posted on each parking meter.

The fee for parking in municipal off-street parking areas shall be at the rate of fifty (50) cents per hour or ten (10) cents for each twelve (12) minute period up to the maximum limit which is posted on each parking meter.

Except as in the following parking space areas as shown in the plans of such Parking Areas attached to Schedule I-A, Section 2, Off-Street Meter Zones, the fee for parking between the hours of 7:00 A.M. and 6:00 P.M. shall be fifty (50) cents per hour or ten (10) cents for each twelve (12) minute period up to the maximum limit which is posted on each parking meter.

Spring Street Parking Area, Library Parking Area, Wells Avenue Parking Area."

<u>Replace</u> with, "With the exception of the Nichols Avenue diagonal parking area, the fee for parking in onstreet parking meter zones shall be at the rate of one (\$1.00) dollar per hour or twenty five (\$.25) cents for each fifteen (15) minute period up to the maximum limit which is posted on each parking meter.

With the exception of the Wells Avenue parking area, the fee for parking in municipal off-street parking areas shall be at the rate of one (\$1.00) dollar per hour or twenty five (\$.25) cents for each fifteen (15) minute period up to the maximum limit which is posted on each parking meter.

Except as in the following parking space areas as shown in the plans of such Parking Areas attached to

Schedule I-A, Section 2, Off-Street Meter Zones, the fee for parking between the hours of 8:00 A.M. and 8:00 P.M. shall be one (\$1.00) dollar per hour or twenty five (\$.25) cents for each fifteen (15) minute period up to the maximum limit which is posted on each parking meter. Wells Avenue Parking Area.

The fee for parking in the Nichols Avenue diagonal parking area, and the Wells Avenue parking area shall be at the rate of fifty (\$.50) cents per hour or twenty five (\$.25) cents for each thirty (30) minute period up to the maximum limit which is posted on each parking meter.
