## LOCAL LAW NO. 1 OF 2024 VILLAGE OF WESTBURY

# A PROPOSED LOCAL LAW AMENDING CHAPTER 1-18 OF THE VILLAGE OF WESTBURY CODE

Be it enacted by the Board of Trustees of the Village of Westbury as follows:

## Section 1. Legislative Intent.

There have been several code changes since Section 1-18 of the code was last amended, which has resulted in some omissions. As a result, the Board finds that an amendment to the Code is appropriate at this time.

**Section 2.** Section § 1-18 of Article IV of the Village Code of the Village of Westbury is hereby amended and restated in its entirety:

"1-18 Designation of employees to issue tickets; applicability of provisions.

A. The Superintendent and Deputy Superintendent of Buildings, Building Inspectors, Code Enforcement Officers, and Complaint Investigators of the village and such other employees of the Building Department as the Mayor may designate from time to time, in writing, filed with the Village Clerk, are hereby authorized and empowered, pursuant to state law, to issue and serve appearance tickets with respect to violations of the provisions of the following provisions of law whenever such violations have been committed by any persons in the presence of any of said village employees:

- 1. All violations of the New York State Uniform Fire Prevention and Building Code;
- 2. All violations of Chapters 70 (Alcoholic Beverages), 74 (Animals), 79 (Building Construction), 83 (Building Rehabilitation), 87 (Buildings, Numbering of), 101 (Block Parties, Exhibitions, Fireworks and Other Special Events), 105 (Contractors' Security for Homes), 112 (Electrical Standards), 117 (Excavations), 121 (Filming), 124 (Fire Prevention), 127 (Flood Damage Prevention), 131 (Gasoline Service Stations and Car Washes), 135 (Graffiti), 139 (Handbills), 142 (Hawking, Peddling and Soliciting), 147 (Illicit Discharges, Activities and Connections to Storm Sewers), 153 (Launderettes), 157 (Licenses and Permits), 164 (Mechanical Bucking Devices), 168 (Noise), 173 (Oil Burners), 176 (Parades), 180 (Peace and Good Order), 184 (Plumbing and Drainage), 187 (Property Maintenance), 191 (Radio Towers), 194 (Recreation Facilities), 198 (Secondhand Merchandise Dealers), 201 (Security Gates), 204 (Sewers), 207 (Shooting Galleries and Rifle Ranges), 209 (Smoking), 211 (Solid Waste), 213 (Stormwater Management), 215 (Streets and Sidewalks), 226 (Taxicabs)

and Prearranged For-Hire Vehicles), 230 (Towing), 237 (Vehicles and Traffic) and 248 (Zoning) of the Village Code.

B. The Superintendent and Deputy Superintendent of Public Works, and such other employees of the Department of Public Works as the Mayor may designate from time to time, in writing, filed with the Village Clerk, are hereby authorized and empowered, pursuant to state law, to issue and serve appearance tickets with respect to violations of the provisions of the following chapters of the Code of the Village of Westbury whenever such violations have been committed by any person in the presence of any of said village employees: Chapters 135 (Graffiti), 147 (Illicit Discharges, Activities, Connections to Storm Sewers), 187 (Property Maintenance), 211 (Solid Waste), 213 (Stormwater Management), and 215 (Streets and Sidewalks).

C. All Parking Enforcement Officers and such other employees of the Village as the Mayor may hereafter designate from time to time, in writing, filed with the Village Clerk, are hereby authorized and empowered to issue and serve parking tickets and appearance tickets for violations relating to parking, local licensing, and noise, including violations of any of the following provisions of the Code of the Village of Westbury whenever such violations have been committed by any person in the presence of any of said village employees: Chapters 168 (Noise), 187 (Property Maintenance); 215 (Streets and Sidewalks); 226 (Taxicabs); 237 (Vehicles and Traffic); and Section 248-6K (Accessory Uses)."

### Section 3. Severability.

If any section or provision of this local law shall be adjudged to be invalid by any court of competent jurisdiction, such judgment shall not affect, impair or invalidate any other part of this local law, or the remainder thereof, but shall be confined in its operation to the section or provision or part thereof directly involved in the controversy in which such judgment shall have been rendered.

#### **Section 4. Effective Date.**

This local law shall take effect immediately upon filing with the Secretary of State.
