ORDINANCE NO. 24-23

An Ordinance to Amend Chapter 6 Boards, Committees and Commission Article I Shade Tree Advisory Committee Section 6.2 Creation; Organization

BE IT ORDAINED by the Mayor and Council of the Borough of Westwood that Chapter 6 Boards, Committees and Commission Article I Shade Tree Advisory Committee Section 6.2 Creation; Organization, is hereby amended as follows (deleted sections are noted by strikethroughs, new sections underlined and bold):

Section 1. Amend:

§ 6-2 Creation; Organization

- A. An Advisory Committee consisting of five ~~persons~~ **regular members and two student advisory members** are hereby created to discharge the duties hereinafter detailed with the goal of preserving the shade trees in the Borough of Westwood.
- B. The Committee shall be organized as follows:
 - 1. There shall be five seats for regular members on the Committee, numbered one through five. **In addition to the five regular members, there may be up to two student members who shall be advisory members appointed in September for one-year terms that coincide with the school calendar.**
 - 2. The initial appointments shall be for a term of years corresponding to the seat number. Thereafter, all appointments shall be for a five-year term.
 - 3. Partial year terms shall expire on December 31, to the end that all terms shall always commence effective January 1 and expire on December 31 as years go by.
 - 4. There shall be elected a Chairman and Secretary by and from the membership of the Shade Tree Advisory Committee.

Section 2. If any section, subsection, paragraph, sentence or any other part of this ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this ordinance.

Section 3. All ordinances or parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 4. If any section, subsection, part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of this Ordinance.

Section 5. This Ordinance shall take effect immediately upon final passage and publication as required by law.
