

ORDINANCE NO. 05 – 2024

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, CHAPTER 104, TITLED “VEHICLES AND TRAFFIC,” SPECIFICALLY TO AMEND SECTION 104-67, TITLED “PARKING TIME LIMITS, CHARGES AND HOURS OF OPERATION FOR VARIOUS PARKING LOTS.”

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester that Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” shall be amended as follows:

SECTION 1. Section 104-67, titled “Parking time limits, charges and hours of operation for various parking lots” shall be amended to read as follows:

“§ 104-67. Parking time limits, charges and hours of operation for various parking lots.

The time limits, charges and hours of operation for the following Borough parking lots shall be as indicated in the chart set forth below.

SECTION 2. SEVERABILITY. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality,

illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

SECTION 3. REPEALER. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 4. EFFECTIVE DATE. This Ordinance shall become effective upon enactment as provided by law.




