Section 91-3 (B) Pool, Swimming - Any structure, basin, chamber or tank which is intended for swimming, diving, recreational bathing or wading and which contains, is designed to contain or is capable of containing water at a depth in accordance with the New York State Uniform Fire Prevention and Building Code currently in effect or in effect in the future.

Section 5. Effective date
This local law shall take effect immediately.
