Chapter 88 Section 12 Meters required

A. All water services, except those used exclusively for fire purposes, shall be metered by meters compatible with the Village's current meter reading system and be approved by the Village prior to the installation of the meter. Beginning with the January 1, 2019 billing cycle, any owner or customer whose water service is not equipped with a meter compatible with the Village's current meter reading system may be assessed a twenty-five dollar (\$25.00) manual read fee which shall be included on the water rents bill and shall become a part of the water rents amount due.

B. Residential water meters up to and including three-fourths-inch shall be furnished by the Department of Public Works at no initial cost to the consumer and maintained by the Department of Public Works and shall remain the property of the Village. Damage to the meter caused by negligence of the consumer or owner will charged to the owner; this includes frozen meters and meters damaged by hot water or other causes. Damages may include the cost for removal, repair, testing and replacement. All water that passes through the meter will be charged to the owner, whether the water is legitimately used or wasted through leakage.

C. Water meters one inch and larger shall be purchased and installed by the owner of the property where the meter is located and maintained by owner. Cost of maintenance of and damage to the meter not caused by the Department of Public Works is the responsibility of the owner of the property where the meter is installed including cost for removal, repair, testing and replacement. All water that passes through the meter will be charged to the owner, whether the water is legitimately used or wasted through leakage.

D. The owner or consumer shall notify the Department of Public Works of any damage to or any cessation in registration of the meter as soon as it comes to his knowledge.
