§63-12. Removal by Village; costs.

In addition, if yards, lawns, and courts are not maintained in a clean, sanitary, and safe condition and free from infestation, it shall be lawful for the Village to cause said yard, lawn, and/or court to be made clean, sanitary, and safe, by removing debris, cutting grass, and taking such other action as may be determined by the Code Enforcement Officer to be reasonably necessary. The Village shall charge for such work a minimum of \$100 plus the regular hourly rate then in effect for such service in excess of \$100, which shall be charged to the person in control and shall also be assessed against the said property and shall be collected, together with interest and penalties thereon, in the same manner as any other taxes provided in the Village. In addition to the rates charged for such services, an administrative fee of \$50 shall be assessed for the first such occasion that the said yard, lawn and/or court is made clean, sanitary and safe by Village crews, \$100 for a second such occasion in the same calendar year and \$200 for a third. Such administrative fees shall also be assessed against the said property and shall be collected, together with interest and penalties thereon, in the same clean, sanitary and safe by Village crews, \$100 for a second such occasion in the same calendar year and \$200 for a third. Such administrative fees shall also be assessed against the said property and shall be collected, together with interest and penalties thereon, in the same manner as any other taxes provided in the Village. Each owner, occupant or person having control of real property in the village of West Carthage will be presumed to have been given sufficient notice of infraction of this Chapter for the entire year following annual notification to the public in a form deemed satisfactory by the Board of Trustees.
