§69-3. Removal by Village.

In addition, if snow, ice or other substance does so collect and remain on any sidewalk, it shall be lawful for the Village to cause the same to be removed as determined by the Code Enforcement Officer at the expense of the owner of said premises. The Village shall charge for such work a minimum of \$100 plus the regular hourly rate then in effect for such services in excess of \$100, which shall be charged to the person in control and shall be assessed against the said property and shall be collected, together with interest and penalties thereon, in the same manner as any other taxes provided in the Village. In addition to the rates charged for such services, an administrative fee of \$50 shall be assessed for the first such occasion that the said sidewalk is not cleared and is cleared by the Village, \$100 for a second such occasion in the same calendar year and \$200 for a third and each subsequent occasion in the same calendar year. Such administrative fees shall also be assessed against the said property and shall be collected, together with interest and penalties thereon, in the same manner as any other taxes provided in the Village. Each owner, occupant or person having control of real property in the Village of West Carthage will be presumed to have been given sufficient notice of infraction of this Chapter for the entire year following annual notification to the public in a form deemed satisfactory by the Board of Trustees.
