Village of West Carthage Local Law No. <u>3</u> of the Year 2023 A Local Law Establishing Zoning Requirements for Cannabis Retail Dispensaries Within the Village of West Carthage

Be it enacted by the Board of Trustees of the Village of West Carthage (the "Board") as follows:

Section 1. Legislative Intent

It is the intent of this local law to establish regulations governing the time, place, and manner of the operation of Cannabis Retail Dispensaries in the Village of West Carthage.

Section 2. Authority

This local law is adopted pursuant to the New York Village Law and the New York Municipal Home Rule Law.

Section 3. Purpose

The purpose of this Proposed Local Law is to amend Sections 91-3, 91-11, and 91-25 to the Code of the Village of West Carthage, more commonly known as the Zoning Law of the Village of West Carthage (the "Zoning Law"), related to the regulation of the time, place, and manner of the operation of Cannabis Retail Dispensaries and On-Site Cannabis Consumption Lounges in the Village of West Carthage.

Section 4. Amendments to Code

See the attached proposed amendments to Sections 91-3, 91-11, and 91-25 of the Zoning Law.

Section 5. State Environmental Quality Review Act (SEQRA)

The Board has considered the provisions of Article 8 of the Environmental Conservation Law ("SEQRA") and the regulations adopted thereunder at 6 NYCRR Part 617 and finds that the proposed amendments to the Zoning Law will not result in any significant adverse environmental impacts. Therefore, no further review is required under SEQRA.

Section 6. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation, or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

Section 7. Effective date

This Local Law shall take effect upon filing with the Secretary of State.

Proposed Amendments (Additions are underlined in bold, red type)

Section 91-3(B) (Definitions; word usage.) of the Zoning Law shall be amended as follows:

CANNABIS

All parts of the plant of the genus Cannabis, whether growing or not; the seeds thereof; the resin extracted from any part of the plant; and every compound, manufacture, salt, derivative, mixture, or preparation of the plant, its seeds, or resin. Cannabis does not include the mature stalks of the plant, fiber produced from the stalks, oil or cake made from the seeds of the plant, any other compound, manufacture, salt, derivative, mixture, or preparation of the mature stalks (except the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of the plant which is incapable of germination. Neither hemp nor cannabinoid hemp are included.

CANNABIS PRODUCTS

<u>Cannabis</u>, concentrated Cannabis, and Cannabis-infused products for use by a consumer.

CANNABIS RETAIL DISPENSARY

Any person or business that is licensed under the provisions of New York State Law to engage in the Retail Sale of Cannabis Products.

CANNABIS CONSUMPTION

The use of a cannabis product in, on, or by the human body for the product's cannabinoid content

RETAIL SALE OF CANNABIS PRODUCTS

To solicit or receive an order for, to keep or expose for sale, and to keep with intent to sell, made by any licensed person, whether principal, proprietor, agent, or employee, of any Cannabis or Cannabis Products.

ON-SITE CANNABIS CONSUMPTION LOUNGE

Any person or business that is licensed under the provisions of New York State Law to permit adult-use on-site consumption of cannabis products at a specified location.

Section 91-11(A) (Central Business Districts.) of the Zoning Law shall be amended as follows:

A. Central Business Districts indicated on the Zoning Map are, for the most part, those areas of the Village on Bridge Street in the general vicinity of the Main Street intersection. The area east of Bridge Street and north of South Main Street to the Pleasant Lake Creek extension is also zoned Central Business District. Business districts are those areas where certain commercial activities occur which are not adjacent to a main arterial highway. In Business Districts, only the following structures and uses shall be permitted:

- (1) Retail stores, shops, banks, business offices, personal service establishments, mortuaries and undertaking establishments.
- (2) Apartments contained in business structures.
- (3) Other uses subject to a special permit approved by the Planning Board are as following:
 - (a) Restaurants, bars, theaters, and recreational establishments operated for profit.
 - (b) Gas stations.
 - (c) Private clubs.
 - (d) Multiple-family dwellings.
 - (e) Essential services
- (4) Other uses subject to a special permit approved by the Board of Trustees of the Village of West Carthage are as follows:
 - (a) <u>Cannabis Retail Dispensaries and other structures and uses</u> concerning the Retail Sale of Cannabis Products
 - (b) On-Site Cannabis Consumption Lounges

Section 91-12 (Arterial Service Districts.) of the Zoning Law shall be amended as follows:

- A. Arterial Service Districts are indicated on the Zoning Map as, for the most part, those areas of the Village on either side of Broad Street from Bridge Street to Champion Street. Uses of shared driveways will be promoted whenever possible. In Arterial Service Districts only the following structures and uses shall be permitted:
 - (1) Retail stores, shops, banks, business offices, personal service establishments, mortuaries, and undertaking establishments.
 - (2) Pet shops, veterinary establishments.
 - (3) Commercial bus facilities.
 - (4) Hotel/motel.
 - (5) Other uses subject to a special permit approved by the Planning Board are as follows:
 - (a) Restaurants, bars, theaters, and recreational establishments operated for profit.
 - (b) Fast-food establishments, convenience stores, malls, shopping centers.
 - (c) Gasoline stations and automobile-related services.
 - (d) Automobile sales, used-car sales facilities, sales or storage of marine uses, recreational vehicles, trailers, mobile homes, manufactured housing, and agricultural implements sales.
 - (e) Essential services.
 - (f) Adult entertainment. (See § 91-26)
 - (g) Hotel/motel.
 - (6) Other uses subject to a special permit approved by the Board of Trustees of the Village of West Carthage are as follows:
 - (a) <u>Cannabis Retail Dispensaries and other structures and uses</u> concerning the Retail Sale of Cannabis Products
 - (b) On-Site Cannabis Consumption Lounges

Section 91-25 (Specific special permit requirements.) of the Zoning Law shall be amended as follows:

- I. <u>Cannabis Retail Dispensary.</u>
 - (1) No on-site consumption of Cannabis Products shall be permitted at a Cannabis Retail Dispensary
 - (2) A Cannabis Retail Dispensary may operate only during the following timeframes: Monday-Saturday 9 a.m. to 9 p.m.; and Sunday 10 a.m. to 6 p.m.
- J. On-Site Cannabis Consumption Lounge
 - (1) The premises shall not be within five hundred feet of school grounds as such term is defined in the New York Education Law or within two hundred feet from a house of worship.
 - (2) There shall not be an opening or means of entrance or passageway for persons or things between the licensed premises and any other room or place in the building containing the licensed premises, or any adjoining or abutting premises, unless ingress and egress is restricted by an employee, agent of the licensee, or other method approved by the Board of controlling access to the facility.
 - (3) An On-Site Cannabis Consumption Lounge may operate only during the following timeframes: Monday-Saturday 5 p.m. to 9 p.m.
