ARTICLE II Terminology

§ 91-3. Definitions; word usage.

- A. When used in this chapter, words in the present tense include the future and words of one gender include all genders. The singular number includes the plural and the plural includes the singular. The term "shall" is intended to be mandatory. Whenever a word or term is defined to "include" certain items or matters, such inclusion is intended to be by way of specification and not of limitation. If interpretation or clarification of any word used in this chapter is needed it shall be provided by the Zoning Board of Appeals in accordance with such powers granted to it.
- B. As used in this chapter, the following terms shall have the meanings indicated:

LONG-TERM STAY HOTEL/MOTEL

A dwelling used for long-term rentals that does not contain cooking facilities, such as a stove, separate from the sleeping and living quarters for each single unit, with seven or more single units in total. Long-term stay hotel/motels are strictly prohibited in the Village of West Carthage.

HOTEL

A building which has a common entrance and general dining room and contains seven or more living and sleeping rooms, designed to be occupied by individuals or groups of individuals for short-term rentals (less than 30 days) only or extended periods of time.

MOTEL

A building or group of buildings not more than two stories in height having direct and convenient access to a main traveled road, intended or designed to provide a series of sleeping units for the accommodation of automobile transients. Each sleeping unit shall consist minimally of a bedroom and a bathroom and shall provide convenient access to a parking space for the unit's occupants. Motels are designed to be occupied by individuals or groups of individuals for short-term rentals (less than 30 days) only.


