AN ORDINANCE AMENDING CHAPTER 373. VEHICLES AND TRAFFIC, ARTICLE XI. SCHEDULES, SECTION 373-14.1 SCHEDULE IXA: THREE-WAY STOP INTERSECTIONS OF THE BOROUGH OF WESTVILLE CODE BOOK (VEHICLES AND TRAFFIC)

WHEREAS, Chapter 373. Vehicles and Traffic, Article XI. Schedules lists the three-way stop intersections in the Borough of Westville (hereinafter referred to as "Borough") under Section 373-37.1 Schedule IXA: Three-Way Stop Intersections; and

WHEREAS, the Borough desires to amend Section 373-37.1 of the Code of the Borough of Westville to add four (4) new three-way stop intersections as follows:

1. Chestnut Street and Cleveland Avenue
2. Chestnut Street and Folsom Street
3. Elm Street and Cleveland Avenue
2. Elm Street and Folsom Street;

and

WHEREAS, numerous residents expressed concerns for vehicles using the streets to bypass Olive Avenue and borough council is recommending the above referenced three-way stop intersections be created; and

WHEREAS, the recommended modifications of the current intersections will result in two (2) new stops on Chestnut Street in the easterly direction, two (2) new stops on Chestnut Street in the westerly direction, two (2) new stops on Elm Street in the easterly direction, and two (2) new stops on Elm Street in the westerly direction

NOW THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Westville, County of Gloucester and State of New Jersey, that Section 373-37.1 Schedule IXA: Three-Way Stop Intersections, is hereby amended to add four (4) new three-way stop intersections as follows:

Section 1.

- A. the intersection of Edgewater Avenue and Klinger Avenue is hereby designated as a three-way stop intersection, and stop signs shall be placed for traffic in both directions on Edgewater Avenue and on Klinger Avenue at its intersection with Edgewater Avenue.
- B. The intersections of Chestnut Street and Cleveland Avenue and Chestnut Street and Folsom Street are hereby designated as three way stop intersections and stop signs shall be placed in all corners of the intersections.
- C. The intersections of Elm Street and Cleveland Avenue and Elm Street and Folsom Avenue are hereby designated as three way stop intersections and stop signs shall be placed in all corners of the intersections.

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3. Severability:

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

Section 4. Effective date:

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.


