AN ORDINANCE AMENDING CHAPTER 373. VEHICLES AND TRAFFIC, ARTICLE XI. SCHEDULES, SECTION 373-14.2 SCHEDULE IXB: FOUR-WAY STOP INTERSECTIONS OF THE BOROUGH OF WESTVILLE CODE BOOK (VEHICLES AND TRAFFIC)

WHEREAS, Chapter 373. Vehicles and Traffic, Article XI. Schedules lists the four-way stop intersections in the Borough of Westville (hereinafter referred to as "Borough") under Section 373-37.2 Schedule IXB: Four-Way Stop Intersections; and

WHEREAS, the Borough desires to amend Section 373-37.2 of the Code of the Borough of Westville to add new four-way stop intersections as follows:

- 1. Oak Avenue and High Street
- 2. Locust Avenue and High Street
- 3. Cedar Avenue and High Street

WHEREAS, numerous residents expressed concerns for vehicles using the streets to bypass Delsea Drive or Broadway and borough council is recommending the above referenced four-way stop intersections be created; and

WHEREAS, the recommended modifications of the current intersections will result in two (2) new Stop Signs on each intersection.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Westville, County of Gloucester and State of New Jersey, that Section 373-37.2 Schedule IXB: Four-Way Stop Intersections, is hereby amended to add new four-way stop intersections as follows:

- D. The intersections of Locust Avenue and High Street and Cedar Avenue and High Street and Oak Avenue and High Street are hereby designated as fourway stop intersections, and stop signs shall be placed at all corners of intersection; and
