

# Ordinance

No. 22-2022

AN ORDINANCE AUTHORIZING THE EXECUTION OF A TEMPORARY EASEMENT AGREEMENT BETWEEN THE BOROUGH OF WESTVILLE AND THE STATE OF NEW JERSEY BY THE COMMISSIONER OF TRANSPORTATION ACROSS BLOCK 34, LOTS 2, 3, 4, 41, 42 AND 43 OWNED BY THE BOROUGH FOR THE ROUTE 47 GROVE STREET TO ROUTE 130 PAVEMENT, SECTION 16, PARCEL E93, PROJECT NO. DEMO-R-0047(310)

*WHEREAS*, there is a need to obtain a Temporary Sidewalk Easement by the State of New Jersey Department of Transportation within the Borough of Westville, across property more particularly described as Block 34, Lots 2, 3, 4, 41, 42 and 43 ("Property"), on the Official Tax Map of the Borough of Westville; and

*WHEREAS*, this property is owned by the Borough of Westville; and

*WHEREAS*, the State of New Jersey Department of Transportation needs the Temporary Sidewalk Easement for the Route 47 Grove Street to Route 130 Pavement Project, Section 16, Parcel(s): E93; and

*WHEREAS*, the State of New Jersey Department of Transportation has agreed to pay to the Borough of Westville the sum of \$1,100.00 under a Temporary Easement Agreement attached hereto and incorporated herein as Exhibit "A", said Agreement being on file and is available for inspection by the public in the Office of the Borough Clerk.

*NOW, THEREFORE BE IT ORDAINED* by the Borough Council of the Borough of Westville as follows:

1. That the Mayor and/or Borough Administrator be and is hereby authorized to execute the Temporary Easement Agreement attached hereto as Exhibit "A" across Block 34, Lots 2, 3, 4, 41, 42 and 43 with the State of New Jersey Department of Transportation for the sum of One Thousand One Hundred Dollars (\$1,100.00).

2. That the Mayor or Borough Administrator, and other such Borough officials as the law provides, are hereby authorized to prepare and execute any documents as may be required for the Temporary Sidewalk Easement across the Property to the New Jersey Department of Transportation.
3. Exhibit "A" shall remain on file in the Borough Clerk's Office and may be viewed during regular business hours.
