

# Ordinance

No. 4-2023

## AMENDING CHAPTER §373, VEHICLES AND TRAFFIC

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Westville, County of Gloucester and State of New Jersey, that the Westville Code Chapter 373-9.1 Parking time limited in Borough parking lots, Chapter 373-30 Schedule II No parking certain hours, Chapter 373-32 Schedule IV Time limit parking is hereby amended to read as follows:

**Section 1. CHAPTER 373-9.1** No person shall park a vehicle for longer than the time limit shown in Schedule IV (Chapter §373-32- Time Limit Parking) at any time between the hours listed in said Schedule IV of any day, except Sundays and public holidays, upon any of the streets or parts of streets described in Schedule IV attached to and made a part of this chapter. Section 9.1\_Parking time limited in Borough parking lots is hereby amended to read as follows:

- A. Where posted in the Borough parking lots on 165, 167, 179 Broadway and designated as official parking, no person shall park a vehicle, other than those so designated, for longer than two hours at any time between the hours of 8:00 a.m. to 7:00 p.m. of any day, except Sundays and public holidays.
- B. Where posted in the Borough parking lots on Crown Point Road and Pine Street, and designated as official parking, no person shall park a vehicle, other than those so designated, at any time between the hours of 8:00 a.m. to 7:00 p.m. of any day, except Sundays and public holidays.
- C. Where posted along Delsea Drive adjacent to 165-167 Broadway, no person shall park a vehicle, for longer than 2 hours at any time except Sundays and public holidays.
- D. In all areas of the property adjacent to the Borough Community Center, Public Library, and the public parking lot, parking is limited to official Library business or Community Center business all hours of all days.
- E. Where posted in the Borough parking lots on 201 Broadway (Rear Lot), no person shall park a vehicle for longer than two hours at any time and day, except Sundays and public holidays.

**Section 2. Chapter 373-32 SCHEDULE II: No Parking Certain Hours** ss hereby amended to read as follows:

- A. Restrictions on all vehicles.

### Section 3. Chapter 373-32 SCHEDULE IV: Time Limit Parking

[Amended 5-28-1975; 4-14-1981; 12-12-1989; 9-10-1991]

In accordance with the provisions of § 373-9, no person shall park a vehicle for longer than the time limit shown upon any of the following streets or parts of streets:

Broadway [Amended 6-15-2015 by Ord. No. 3-2015]	East	All	2 hours	Between Center Street and Delsea Drive
Broadway [Added 3-24-2010 by Ord. No. 2-2010]	East	7:00 a.m. to 8:00 p.m., all days	15 minutes	From a point 182 feet from the northerly curblines of Center Street to a point 235 feet north of the northerly curblines of Center Street
Broadway [Added 9-27-2000]	North	7:00 a.m. to 9:00 p.m.	1 hour	From the northerly curblines of Harvard Avenue to a point 140 feet north thereof
Broadway [Amended 6-15-2015 by Ord. No. 3-2015]	West	All	2 hours	From Delsea Drive to the northerly curblines extension of Duncan Avenue
201 Broadway (Rear Lot)	East	All	2 hours	Entire Lot

**Section 4. Repealer.**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**Section 5. Severability.**

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

**Section 6. Effective date:**

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
