**AN ORDINANCE OF THE TOWN OF WEST NEW YORK,  
IN THE COUNTY OF HUDSON, NEW JERSEY,  
APPROPRIATING GRANTS FOR VARIOUS PARK  
PROJECTS IN AND FOR THE TOWN OF WEST NEW  
YORK**

THE BOARD OF COMMISSIONERS OF THE TOWN OF WEST NEW YORK, IN THE COUNTY OF HUDSON, NEW JERSEY, DO ORDAIN AS FOLLOWS:

Section 1. The \$485,810 Community Development Block Grant for Donnelly Park Improvements referenced in Resolution No. 682-10-2023 adopted by the Board of Commissioners of Hudson County on October 26, 2023, is hereby appropriated for improvements to Donnelly Park and including all work and materials necessary therefor and incidental thereto.

Section 2. The \$468,387 Community Development Block Grant for Fillmore and Verrazano Park Improvements referenced in Resolution No. 682-10-2023 adopted by the Board of Commissioners of Hudson County on October 26, 2023, is hereby appropriated for improvements to Fillmore Park and Verrazano Park and including all work and materials necessary therefor and incidental thereto.

Section 3. The \$400,000 Open Space Grant from the Hudson County Open Space Trust Fund for the Washington Park Improvement Project as set forth in the letter from the County dated August 23, 2023 and the \$453,107 Community Development Block Grant for Washington Park Improvements referenced in Resolution No. 427-7-2023 adopted by the Board of Commissioners of Hudson County on July 13, 2023, are hereby appropriated for improvements to Washington Park and including all work and materials necessary therefor and incidental thereto.

Section 4. The \$300,000 Open Space Grant from the from the Hudson County Open Space Trust Fund for Phase 3 of the Miller Park Improvements as set forth in the letter from the County dated June 10, 2022, is hereby appropriated for improvements to Miller Park or for such alternate park projects as may be approved by Hudson County and including all work and materials necessary therefor and incidental thereto.

Section 5. The capital budget or temporary capital budget, as applicable, of the Town is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Town Clerk and is available there for public inspection.

Section 5. This ordinance shall take effect in accordance with applicable law.
