AN ORDINANCE OF THE TOWN OF WEST NEW YORK, IN
THE COUNTY OF HUDSON, NEW JERSEY, APPROPRIATING
\$152,358.60 FOR THE AUTOMATED LICENSE PLATE
READER INITIATIVE IN AND FOR THE TOWN OF WEST
NEW YORK

THE BOARD OF COMMISSIONERS OF THE TOWN OF WEST NEW YORK, IN THE
COUNTY OF HUDSON, NEW JERSEY, DO ORDAIN AS FOLLOWS:

Section 1. \$152,358.60, consisting of a \$125,380 grant from the State of New Jersey Department of Law and Public Safety through the American Rescue Plan (ARP) Act – 2021 Coronavirus State Fiscal Recovery Fund Automated License Plate Reader Initiative and \$26,978.60 from the Town’s general capital fund – fund balance, is hereby appropriated for the Automated License Plate Reader Initiative, including all work and materials necessary therefor and incidental thereto.

Section 2. The capital budget or temporary capital budget, as applicable, of the Town is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Town Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect in accordance with applicable law.
