

01 ORDINANCE NO. 2025 - 01

**BOROUGH OF WEST GROVE
CHESTER COUNTY**

AN ORDINANCE AUTHORIZING A DECREASE IN TAXES LEVIED AND COLLECTED FOR STREET LIGHTING AND AN INCREASE IN TAXES LEVIED AND COLLECTED FOR THE GENERAL FUND, BEGINNING JANUARY 2026, PURSUANT TO BOROUGH CODE SECTION 1302.

WHEREAS, Section 1302 of the Borough Code, 8 Pa.C.S. §1302, authorizes Borough Council of the Borough of West Grove to levy and collect annual taxes; and

WHEREAS, Section 1302 of the Borough Code, 8 Pa.C.S. § 1302, authorizes Borough Council of the Borough of West Grove to amend taxes levied and collected from time to time by ordinance; and

WHEREAS, the Borough of West Grove currently levies and collects taxes at a rate of 5.0 mills for the General Fund; and

WHEREAS, the Borough of West Grove currently levies and collects taxes at a rate of 0.5 mills for Street Lighting; and

WHEREAS, pursuant to Section 1302 of the Borough Code, the Borough of West Grove hereby increases the taxes levied and collected for the General Fund to 5.25 mills; and

WHEREAS, pursuant to Section 1302 of the Borough Code, the Borough of West Grove hereby decreases the taxes levied and collected for Street Lighting to 0.25 mills; and

WHEREAS, these amendments to taxes levied and collected, as ordained and enacted herein, shall take effect beginning in the 2026 calendar year; and

WHEREAS, Borough Council of the Borough of West Grove may further amend taxes levied and collected from time to time, as permitted by the Borough Code.

BE IT AND IT IS HEREBY ENACTED and ORDAINED by the Borough Council of the Borough of West Grove, Chester County, as follows:

Section 1. Beginning January 1, 2026, the Borough of West Grove shall increase the taxes levied and collected for the General Fund to 5.25 mills.


Section 2. Beginning January 1, 2026, the Borough of West Grove shall decrease the taxes levied and collected for Street Lighting to 0.25 mills.

Section 3. Severability. If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective.


Section 4. Effective Date. This Ordinance shall become effective five (5) days from the date of enactment.






