ORDINANCE 2024-05

ORDINANCE PROVIDING FUNDING FOR VARIOUS CAPITAL IMPROVEMENTS FOR THE WATER/SEWER UTILITY FOR THE TOWNSHIP OF WEST DEPTFORD AND APPROPRIATING \$15,000,000 FOR SUCH PURPOSE.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST DEPTFORD, IN THE COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY, AS FOLLOWS:

- Section 1. The Township of West Deptford, in the County of Gloucester, New Jersey, authorizes various capital improvements for the water/sewer utility, per the Agreement with Solvay entered into by Resolution on 2024-82 adopted on January 31, 2024 and Ordinance 2024-02 adopted on February 21, 2024 to create an established account for all specific capital improvements, specified under same including PFAS treatments and well Installation for Municipal Well 3, PFAS Treatment for Well 4, and PFAS Treatment of Well 5 including all work and materials necessary therefor and incidental thereto for the Township of West Deptford to be funded from the sources specified in Section 2 of the Ordinance.
- Section 2. The amount of \$15,000,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the Water and Sewer Capital Reserve in the amount of \$15,000,000, per the agreement with Solvay entered into by Resolution 2024-82 on January 31, 2024, and Ordinance 2024-02 adopted on February 21, 2024.
- Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Township determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the Township of West Deptford may lawfully make as a general improvement.
- <u>Section 4</u>. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.
- <u>Section 5</u>. This Ordinance shall take effect immediately upon due passage and publication according to law.
