#### **ORDINANCE #2024-15**

## AN ORDINANCE VACATING A PORTION OF HATHAWAY AVENUE (A PAPER STREET) IN THE TOWNSHIP OF WEST DEPTFORD, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY

**BE IT ORDAINED** by the Mayor and Township Committee of the Township of West Deptford, in the County of Gloucester and State of New Jersey as follows:

## Section 1. Hathaway Avenue

The Township of West Deptford does hereby vacate any right, title, or interest in a portion of Hathaway Avenue (i.e., paper street) from Grove Avenue to the beginning of Laurel Avenue situated in the Township of West Deptford, County of Gloucester and State of New Jersey bounded and described as follows:

See attached Exhibit A (highlighted Tax Map).

#### Section 2.

Pursuant to N.J.S.A. 40:67-1(b), all rights and privileges, if any, presently possessed by the Township of West Deptford, and/or Water & Sewer Department, any public utilities and any cable television company to maintain, repair, and replace their existing facilities in, adjacent to, over or under the public streets herein vacated, are hereby expressly reserved and excepted from vacation.

#### Section 3.

Pursuant to N.J.S.A. 40:67-21, a certified copy of the within Ordinance shall be filed with the Gloucester County Clerk and recorded in the Book of Vacations in the office of said Gloucester County Clerk within sixty (60) days after the within Ordinance is finally adopted and becomes effective.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon final passage and publication as required by law.
