ORDINANCE # 2024-16

AN ORDINANCE OF THE TOWNSHIP OF WEST DEPTFORD APPROPRIATING \$200,000 FROM THE CAPITAL IMPROVEMENT FUND FOR VARIOUS CAPITAL IMPROVEMENTS IN THE TOWNSHIP OF WEST DEPTFORD

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AS FOLLOWS:

<u>Section 1</u>. The Township of West Deptford, in the County of Gloucester, New Jersey, authorizes various capital improvements to be funded from sources specified in Section 2 of the Ordinance.

<u>Section 2</u>. The amount of \$200,000.00 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the General Capital Improvement Fund in the amount of \$200,000.00.

- A. IT Infrastructure Upgrades \$175,000.00
- B. Police Equipment \$25,000.00

<u>Section 3</u>. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith.

<u>Section 4</u>. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Township determines the purpose described in Section 1 hereof is not a Current Expense and is a capital purchase which the Township of West Deptford may lawfully make as a general improvement.

<u>Section 5.</u> All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

<u>Section 6.</u> This ordinance shall take effect after final adoption and publication as required by law.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
