## AN AMENDMENT TO THE TRAFFIC ORDERS OF THE TOWN OF WEST SPRINGFIELD

Elm Street - No Right Turn on Red

WHEREAS, the Traffic and Safety Committee is charged with maintaining and improving the Traffic Orders for the Town of West Springfield; and

WHEREAS, the Committee has determined that there exists an issue with the phasing and geometry of the Elm Street and Kings Highway intersection; and

WHEREAS, the Committee has determined that a No Right Turn on Red designation on the southbound direction of Elm Street traffic would be a benefit to the community; and

WHEREAS, it is in the best interests of the Town to amend Traffic Orders.

NOW THEREFORE, the West Springfield Town Council hereby resolves, ordains, amends, and enacts the following changes to Chapter 400 (Traffic Orders), of the Code (Ordinances) of the Town of West Springfield:

**Ordered:** by the West Springfield Town Council that the Chapter 400 of the Code (Ordinances) of the Town of West Springfield is hereby amended as follows:

Division 3 Rules and Regulations

Chapter 400 Traffic Orders

Article VI Operation of Vehicles

§ 400-39 Obedience to Traffic Control Signs.
