### **AN AMENDMENT TO THE GENERAL ORDINANCES RELATIVE TO SPEED HUMPS**

**Ordered:** by the West Springfield Town Council that Chapter 218 of the Code (Ordinances) of the Town of West Springfield is hereby amended as follows:

<b>Division 1</b>	<b>General Ordinances</b>
<b>Part II</b>	<b>General Legislation</b>
<b>Chapter 218</b>	<b>Streets and Sidewalks</b>
<b>Article VII</b>	<b>Speed Humps</b>


***Add the following language:***

#### **§ 218-50    Alternate Petitioners**

The Department of Public Works may elect to install speed humps at the discretion of the Director with approval of the Mayor. The provisions of § 218-43, § 218-44, § 218-48 do not apply when the Town Engineer/DPW Director is the petitioner. The Town Council, through a majority vote of the Traffic & Safety Subcommittee, may serve as the petitioner. The provisions of § 218-43, do not apply when the Town Council is the petitioner.


