

### **ROOM OCCUPANCY EXCISE TAX** **Pursuant to Massachusetts General Laws Chapter 64G, Section** **3A**

**Ordered:** that, the Town Council, hereby affirms its acceptance of the provisions of Massachusetts General Laws Chapter 64G, Section 3A, as amended, and imposes a local excise tax upon the transfer of occupancy of any room or rooms in a bed and breakfast establishment, hotel, lodging house or motel located within the Town at a rate of six percent (6%) of the total amount of rent for each such occupancy, effective July 1, 2024.




