AN AMENDMENT TO THE TRAFFIC ORDERS OF THE TOWN OF WEST SPRINGFIELD

Special Speed Regulation- 25 Miles Per Hour Speed Limit on River Street and South Boulevard

WHEREAS, the Traffic and Safety Committee is charged with maintaining and improving the Traffic Orders for the Town of West Springfield; and

WHEREAS, the Committee has determined that the Department of Public Works have safety concerns relative to its traffic; and

WHEREAS, the Committee has determined that a twenty-five (25) Miles Per Hour Speed Limit on River Street and South Boulevard would be a benefit to the community; and

WHEREAS, it is in the best interests of the Town to amend Traffic Orders.

NOW THEREFORE, the West Springfield Town Council hereby resolves, ordains, amends and enacts the following changes to Chapter 400 (Traffic Orders), of the Code (Ordinances) of the Town of West Springfield.

Ordered: by the West Springfield Town Council that the Chapter 400 of the Code (Ordinances) of the Town of West Springfield is hereby amended as follows:

Division 3 Rules and Regulations
Chapter 400 Traffic Orders
Attachment 1: Special Regulations:

Add the following language:

In accordance with the provisions of Mass. Gen. Laws Ch. 90 § 18(2006), the following speed limits are established at which motor vehicles may be operated in the areas described:

SOUTH BOULEVARD (Hampden Street to River Street)


South Boulevard from Hampden Street to River Street on its southbound direction of travel.

RIVER STREET (Baldwin Street to Park Street)

River street from a distance of 200 feet South of Baldwin Street to Park Street in both directions.






