# TOWN OF WESTFIELD LOCAL LAW NO. 3 FOR THE YEAR 2022

## **EXEMPTING ELIGIBLE FACILITIES REQUESTS FROM SPECIAL USE PERMIT REQUIREMENTS**

Be it enacted by the Town of Board of the Town of Westfield, County of Chautauqua and State of New York, as follows:

### SECTION 1. EXEMPTION FOR "ELIGIBLE FACILITES REQUESTS"

A new Section 185-43(3)(d) is hereby added to the Town of Westfield Zoning Code, which shall provide as follows:

(d) These regulations and their requirement for the issuance of a special use permit shall not apply to modifications to existing telecommunications facilities determined by the Code Enforcement Officer to be "Eligible Facility Requests", as set forth in 47 C.F.R. Section 1.6100(b)(3), as that section may be amended from time to time; provided, however, that applicants for such modifications shall obtain a non-discretionary zoning permit from the Code Enforcement Officer, subject to any applicable fee as set from time to time by resolution of the Town Board.

#### SECTION 2. VALIDITY AND SEVERABILITY

If any part or provision of this Local Law shall be declared invalid, void, unconstitutional or unenforceable by a court of law, all unaffected provisions hereof shall survive such declaration and this Local Law shall remain in full force and effect as if the invalidated portion had not been enacted.

#### SECTION 3. EFFECTIVE DATE

This Local Law shall take effect immediately upon it being filed in the office of the Secretary of State.
