**AN ORDINANCE FIXING THE REAL ESTATE TAX RATE FOR  
 THE BOROUGH OF WELLSBORO FOR THE YEAR 2022.**

**BE IT ORDAINED AND ENACTED**, by the Borough Council of the Borough of  
 Wellsboro, Tioga County, Pennsylvania, as follows:

That a tax be and the same is hereby levied on all real property within the Borough subject to  
 taxation for the fiscal year 2022 as follows:

Tax rate for general purposes, the sum of .....	7.133 mills
On each dollar of assessed valuation, or the sum of .....	.007133 cents
On each one hundred dollars of assessed valuation.	
For debt purposes, the sum of .....	_____ mills
On each dollar of assessed valuation, or the sum of .....	_____ cents
On each one hundred dollars of assessed valuation.
