

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-14.3 PARKING TIME LIMITED ON CERTAIN STREETS DURING CERTAIN HOURS OF CERTAIN DAYS AND SUBSECTION 7-26.1, BUS STOPS, OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE**

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey, as follows:

**Section 1.** Subsection 7-14.3 Parking Time Limited on Certain Streets During Certain Hours of Certain Days of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

<b>Main Street</b>	<b>East</b>	<b>2 Hours</b>	<b>8AM-8PM</b>	<b>Mon-Sat</b>	<b>Starting 84 feet south of the southerly curbline of Harrison Avenue extended, and extending 107 feet south.</b>

**Section 2.** Subsection 7-26.1 Bus Stops of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Street

Bus Route #21

Along Main Street, northbound on the easterly side thereof at:

*Ashwood Terrace (far side). Beginning 75 feet north of the northerly curbline of Ashwood Terrace and extending 100 feet northerly thereof.*

**Ashwood Terrace (far side). Beginning at the northerly curbline of Ashwood Terrace extended and extending 94 feet northerly.**

**Section 3.** If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of the Ordinance are severable.

**Section 4.** All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

**Section 5.** This Ordinance will take effect upon final passage, publication in accordance with law and the approval of the Essex County Board of Commissioners since Main Street is a County Road.

## **LEGISLATIVE HISTORY**

The Ordinance, which amends the Traffic Regulations of the Township, creates both two hour and fifteen minute time limited parking zones on both sides of Main Street for the convenience of business patrons in the Lourdes/Eagle Rock shopping district. This action is in response to requests for more turnover in the available spaces, which tend to be taken by nearby residents or business owners who park all day. The time limited parking will be in effect from 8:00 am to 8:00 pm, Monday through Saturday. The Ordinance also revised the location of the existing Bus Stop on the easterly side of Main Street just north of Ashwood Terrace. This Bus Stop will be closer to the intersection with Ashwood Terrace to allow more on street parking closer to the business district.
