

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-13, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS, AND ADDING SUBSECTION 7-13.1 EMERGENCY PARKING ON LINDSLEY AVENUE OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE**

**BE IT ORDAINED**, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-13, Parking Prohibited at All Times on Certain Streets, of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Sides	Location
<i>Lindsley Avenue</i>	<i>North</i>	<i>Main Street to Laird Drive</i>
<b>Lindsley Avenue</b>	<b>North</b>	<b>Main Street to Laird Drive except for Emergency Vehicles as set forth in 7-13.1</b>

Section 2. Subsection 7-13.1, Emergency Vehicle Parking on Lindsley Avenue, of the Township of West Orange is hereby added as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Sides	Location
<b>Lindsley Avenue</b>	<b>North</b>	<b>Beginning 47' west of the westerly curb line of Main Street extended, and extending 120' west, and then beginning 114' feet east of the easterly curb line of Wheeler Street extended and extending 80' west</b>

Section 3. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of this Ordinance are severable.

Section 4. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 5. This Ordinance shall take effect upon final passage and publication in accordance with law.

**LEGISLATIVE HISTORY**

This change was requested by Police Administration, who wanted extra parking for Emergency Vehicles on the street, in the event that Township-owned parking lot overflows.
