

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-7.3, TEMPORARY PARKING PROHIBITION FOR SNOW PLOWING AND REMOVAL, SUBSECTION 7-12 PARKING PROHIBITED FOR STREET CLEANING AND MAINTENANCE, 7-13 NO PARKING ANYTIME, AND 7-14.1C NIGHT PARKING PROHIBITED, OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-7.3, Temporary Parking Prohibition for Snow Plowing and Removal of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Sides	Location
Undercliff Terrace South	Both	Walker Road to the Northerly Dead End

Section 2. Subsection 7-12, Parking Prohibited for Street Cleaning and Maintenance of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Side	Hours/Day	Location
Undercliff Terrace South	East	9AM-1PM Thursday	Walker Road to the Northerly Dead End

Section 3. Subsection 7-13 Parking Prohibited at All Times on Certain Streets of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Side	Location
Undercliff Terrace South	West	From the northerly curbline of Walker Road extended to the Southerly property line of # 1 Undercliff Terrace South

Section 4. Subsection 7-14.1C Night Parking Restricted of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Exceptions:

Name of Street	Sides	Location
Undercliff Terrace South	East	Walker Road to the northerly Dead End
Undercliff Terrace South	West	In front of House #1 only

Section 5. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of this Ordinance are severable.

Section 6. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 7. This Ordinance shall take effect upon final passage and publication in accordance with law.

LEGISLATIVE HISTORY

This Ordinance amends the Revised General Ordinances of the Township of West Orange Chapter 7-7.3 Temporary Parking Prohibition for Snow Plowing and Removal, Chapter 7-12 Parking Prohibited for Street Cleaning and Maintenance, Chapter 7-13, Parking Prohibited at All Times on Certain Streets, and Chapter 7-14.1C Night Parking Restricted on the northerly section of Undercliff Terrace South. This change was requested by the Homeowners on this street, who petitioned for overnight parking in front of their homes.
