

**AN ORDINANCE AMENDING CHAPTER 13, SECTION 7.5 OF THE REVISED
GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE
(FIRE SYSTEM FEES)**

**BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF
WEST ORANGE, NEW JERSEY** that Chapter 13, Section 7.5 of the Revised General
Ordinances of the Township of West Orange be and are hereby amended as follows:

I. PURPOSE

The purpose of this ordinance is to modify the fines set forth in Chapter 13, Section 7.5 of
the Revised General Ordinances of the Township of West Orange (the "Township Code") to be
amendable by Resolution such that it is amendable in the future by approval of the Township
Council, a necessity in an everchanging socioeconomic climate.

**II. CHAPTER 13, SECTION 7.5 SHALL BE AND HEREBY IS AMENDED AND
SUPPLEMENTED TO INCORPORATE THE FOLLOWING:**

§13-7.5 BE AND HEREBY AMENDED AS FOLLOWS:

- The portion entitled "Fire System Fees" which specifies the fee in connection with
specific categories of inspections and/or permits shall be repealed and replaced by the
following language:

In connection with this subsection, the following
inspection/permit fees shall be charged:

a. Kitchen Suppression System.

1. Hood — ~~\$75~~ an amount set forth by
