AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-32.2 RESTRICTED PARKING ZONES and 7-32.1 HANDICAPPED PARKING ON STREETS OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

<u>Section 1.</u> Subsections 7-32.2, Restricted Parking Zones and 7-32.1 Handicapped Parking on Streets, of the Revised General Ordinances of the Township of West Orange are hereby supplemented and amended as follows (*italic type denotes deletion*, **bold type denotes addition**):

7-32.2 Restricted Parking Zones. Pursuant to N.J.S.A 39:4-197.6, Restricted Parking Zones, as defined in N.J.S.A. 39:4-207.6e, are established in front of the following residences as indicated on the Tax Maps of the Township of West Orange, at the specified locations. Parking within a specific zone is restricted to the motor vehicle issued a permit pursuant to N.J.S.A. 39:4-197.7. In accordance with N.J.S.A., 39:4-197.6 parking is permitted in the Restricted Parking Zone except when prohibited in front of the residence by other sections of this Chapter.

85 Mitchell Street	1	Beginning 366 feet east of the easterly curb line of Rollinson Street and extending 22 feet east.

5 Glennon Place	1	Beginning 82 feet west of the westerly curb line of Sayers Place and extending 21 feet west.
100 Maple Street	1	Beginning 360 feet west of the westerly curb line of Harrison Avenue And extending 19 feet west.
131 Franklin Avenue	1	Beginning 450 feet south of the southerly curb line of Cherry Street and extending 20 feet south.

Beginning 63 feet east of the easterly curb line of Oak Terrace and extending 20 feet east.

Subsection 7-32.1, Handicapped Parking on Streets, of the Revised General Ordinances of the

Township of West Orange is hereby supplemented and amended as follows (italic type denotes deletion,

bold type denotes addition):

In accordance with the provisions of N.J.S.A. 39:4-197, the following on-street locations are designated as handicapped parking places. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the New Jersey Motor Vehicle Commission, or a temporary placard issued by the Chief of Police. No other person shall be permitted to park in these places.

31 Westview Road

Beginning 70 feet from the northerly curb line of Northfield Avenue extended and extending 22 feet north.

<u>Section 2.</u> If any provision of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any other provisions or applications of this Ordinance that can be given effect without the invalid provision(s) or application(s) and to this end the provisions of this Ordinance are severable.

Section 3. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are

hereby repealed.

<u>Section 4.</u> This Ordinance shall take effect upon final passage and publication in accordance with law and upon the approval of the New Jersey Department of Transportation if required.

LEGISLATIVE HISTORY

This Ordinance is in response to requests from handicapped residents who reside at 85 Mitchell Street, 65 High Street, 5 Glennon Place, 100 Maple Street, 131 Franklin Avenue, and 6 Marmon Terrace.

Additionally, a Township Dentist requested a handicapped parking space be located on the street adjacent to his business for the convenience of his patients. This space will be available for use by anyone issued a NJMVC handicapped placard or license plate.

By adopting this Ordinance, the Township will establish a handicapped parking stall adjacent to each of these addresses. Such parking stalls are permissible under the laws of New Jersey, and they are designated as Restricted Parking Zones.
