

**AN ORDINANCE AMENDING CHAPTER 7, SECTION 37.1 AND CHAPTER 7, SECTION 50.3(h) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE
(REGULATION FOR THE MOVEMENT AND PARKING OF TRAFFIC ON MUNICIPAL AND BOARD OF EDUCATION PROPERTY)
(PARKING METERS IN PARKING YARDS—PROHIBITED PARKING)**

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF WEST ORANGE, NEW JERSEY that Chapter 7, Section 37.1 and Chapter 7, Section 50.3(h) of the Revised General Ordinances of the Township of West Orange be and are hereby amended as follows:

I. PURPOSE

The purpose of this ordinance is to amend the Township of West Orange Municipal Code (the “Township Code”) Chapter 7, Section 37.1 and Chapter 7, Section 50.3(h) related to “Parking Yards” such that the parking yard located on the tax map as Table “A” and highlighted in yellow is added. Further, the Township Engineer has evaluated the width of Wheatland Avenue and found Wheatland Avenue is a narrow roadway with limited room for the passage of emergency vehicles, snow removal vehicles, and/or Township owned vehicles. Additionally, the Chief of Police and the West Orange Police Department have received complaints from residents regarding the parking in the area denoted in Table “A,” which is owned by the Township. Thus, because the area in Table “A” is a parking yard pursuant to the Township Code, the Township seeks to amend Chapter 7 Section 37.1 and Chapter 7, Section 50.3(h) to include the area known as “Cable Rd.,” denoted in Table “A” and require permit parking only for residents of Wheatland Avenue on the same.

II. CHAPTER 7, SECTION 37.1 SHALL BE AND HEREBY IS AMENDED AND SUPPLEMENTED TO INCORPORATE THE FOLLOWING:

§7-37.1 BE AND HEREBY AMENDED AS FOLLOWS:

- The portion entitled “Regulation for the Movement and Parking of Traffic on Municipal and Board of Education Property” which specifies, in accordance with N.J.S.A. 39:4-197, the following Municipal and Board of Education Property wherein movement of traffic is controlled by the type of regulation that is indicated herein and shall be repealed and replaced by the following language:
 - a. Parking Prohibited at All Times in Certain Designated Areas. No person shall park a vehicle or other encumbrance at any time upon any of the areas described. These areas shall be posted as required under the provisions of N.J.S.A. 39:4-197g. The provisions of this subsection are not applicable to Fire, Police and other emergency vehicles.

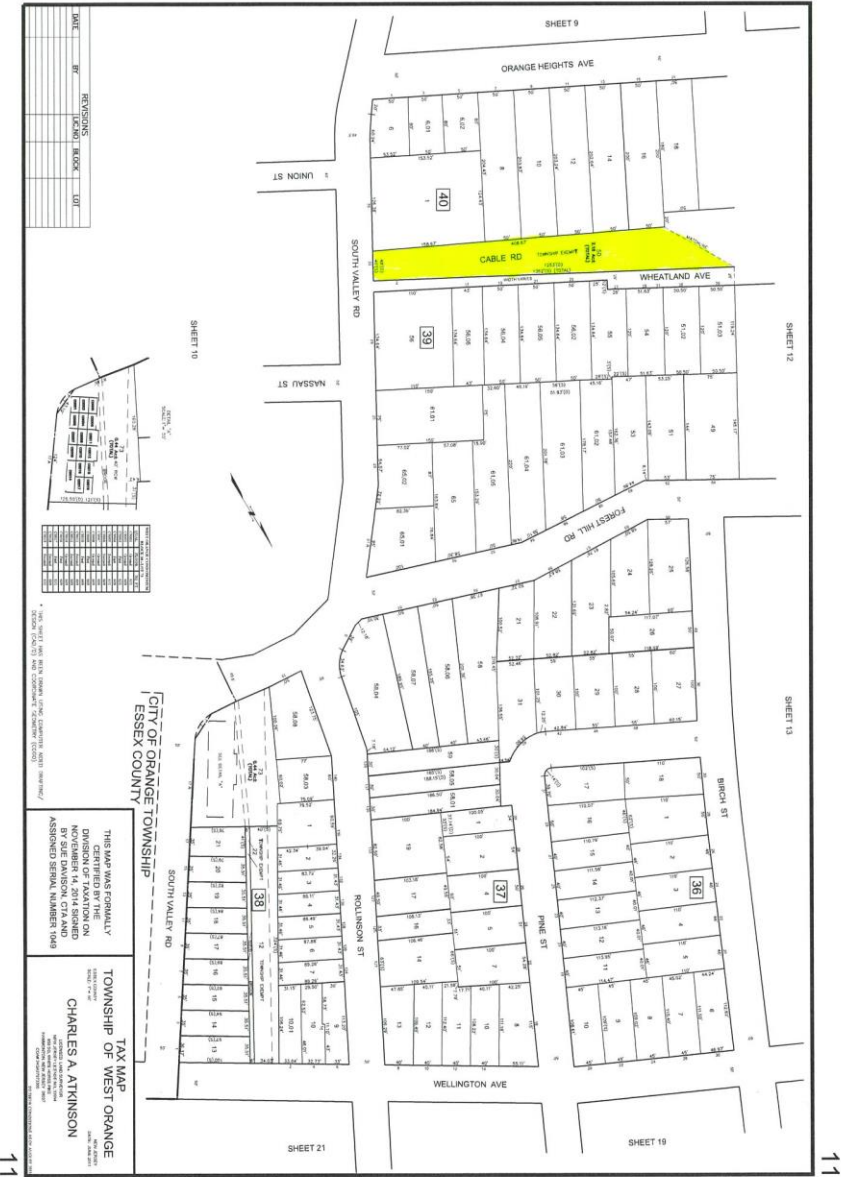

[2] Only property owners whose property is located on Wheatland Avenue or South Valley Road between Forest Hill Road and Orange Heights Avenue are eligible for a permit for Municipal Parking Yard 17. Wheatland Avenue, Forest Hill Road, and/or Orange Heights Road are eligible to receive a permit for parking in the area designated in Table "A" pursuant to Chapter 7, Section 50.3(f) of the Township of West Orange Municipal Code.

III. CHAPTER 7, SECTION 50.3(h) SHALL BE AND HEREBY IS AMENDED AND SUPPLEMENTED TO INCORPORATE THE FOLLOWING:

§7-50.3(h) BE AND HEREBY AMENDED AS FOLLOWS:

- The portion entitled “Parking Meters in Parking Yards—Prohibited Parking” which specifies who can apply for a permit in a Municipal Parking Yard and shall be repealed and replaced by the following language:
 - h. Prohibited Parking. It shall be unlawful for any person to cause, allow, permit or suffer any vehicle registered to his/her name or occupied by him/her to be parked in any municipal parking yard, lot, or facility except in the manner provided in Subsections 7-50.3d and 7-50.3f, and with the following additions:
 1. No vehicle shall occupy any space designated for permit parking, at any time, without a parking permit, valid for the lot in which the vehicle is parked.
 - ~~2. — Parking Yard #7 on Mount Pleasant Avenue is intended solely for the use of library patrons and employees. Parking is permitted in this parking yard only during library hours.~~
 23. No person shall park in any municipal parking yard, lot, or facility that has been designated and reserved by the Business Administrator, with or without meters, for the exclusive use of authorized Township employees and authorized Township personnel. All such areas shall be marked and posted by the Business Administrator, who shall cause to be issued to all Township employees and authorized Township personnel, an official sticker insignia that shall be affixed to the left rear window of any vehicle authorized in these reserved areas. It shall be unlawful and a violation of the provisions of this subsection for any unauthorized use of designated municipal parking yards, lots, or facilities.
 34. For Municipal Parking Yard #13:
 - a. Public parking is prohibited between the hours of 9:00 p.m. and 7:00 a.m. each day and all day Sunday.
 - b. Vehicles registered greater than 8,000 GVW are prohibited from parking in Yard #13.
Parking Yard #13 includes the portions of lots 12 and 14 of Block 176.05, commonly known as 463-481 Pleasant Valley Way, depicted on the plan entitled "Pleasantdale Presbyterian Church Parking Lot Improvement" prepared by the Engineering Division

of the Township of West Orange, April 1999.

- 45. Parking Yard #15 on Cherry Street is intended solely for the use of the employees of the West Orange Recreation Department, visitors to the Recreation Department offices at 60 1/2 Cherry Street, patrons of the Ginny Duenkel Municipal Pool, and visitors of Colgate Field. Six parking stalls are restricted for use by Recreation Department employees. The remaining four stalls are for use by the other persons authorized above and are subject to a one hour time limit.
- 56. With the exception of Parking Yard #5 on Hazel Avenue and Parking Yard #13, parking in any lot between the hours of 2:00 a.m. and 5:00 a.m. is prohibited unless the vehicle bears a permit as provided in Subsection 7-50.3f.
- 67. For Municipal Parking Yard #5 on Hazel Avenue, parking is prohibited between the hours of 6:00 p.m. and 6:00 a.m. unless the vehicle bears a permit as provided in Subsection 7-50.3f.
- 78. For Municipal Parking Yard #11 on Seward Street, parking by commercial vehicles as defined in Subsection 7-14.10 is hereby prohibited.
- 89. For Municipal Parking Yard # 17 on Cable Road as denoted by Table "A" to Subsection 7-37.1, Only property owners whose property is located on Wheatland Avenue or South Valley Road between Forest Hill Road and Orange Heights Avenue are eligible for a permit for Municipal Parking Yard 17.
