ORDINANCE AMENDING CHAPTER 2, SECTION 62 OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF WEST ORANGE, NEW JERSEY that Chapter 2 of the Revised General Ordinances of the Township of West Orange be and are hereby amended as follows:

I. PURPOSE

The purpose of this ordinance is to revise the membership and certain operational aspects of the Board.

II. CHAPTER 2, SECTION 62.3 ENTITLED MEMBERSHIP BE AND IS HEREBY AMENDED AS FOLLOWS:

- a. Four (4) members appointed by the Mayor, one (1) of whom shall be designated Secretary of the Board.
- b. One (1) member appointed by each Township Councilperson for a total of five (5).
- c. Two (2) Council consensus appointments.

III. CHAPTER 2, SECTION 62.5 ENTITLED ORGANIZATIONAL STRUCTURE BE AND IS HEREBY AMENDED AS FOLLOWS:

- b. The Mayor-Board shall appoint a Chairperson and Vice Chairperson.
- c. The Chair and Vice Chairperson shall be elected by the Board by a majority vote for a term of one (1) year. The Chair and Vice Chairperson may be elected for multiple one (1) year terms.
- d. The Board shall meet monthly.
- e. The Secretary shall take minutes for each meeting of the Board. ~~nMinutes of each meeting of the Board shall be taken to serve as a public record.~~ Approved minutes shall be ~~sent-provided~~ to the Municipal Clerk for distribution to the, Mayor and Township Council.
