## AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-25, LOADING ZONES, SUBSECTION 7-14.7, ALTERNATE SIDE PARKING, AND 7-14.1, NIGHT PARKING RESTRICTED OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

**BE IT ORDAINED,** by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-25, Loading Zones, of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion*, **bold type denotes addition**):

Section 2. Subsection 7-14.7, Alternate Side Parking, of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion*, **bold type denotes** addition):

## **LEGISLATIVE HISTORY**

This Ordinance amends the Revised General Ordinances of the Township of West Orange Chapter 7-25, Loading Zones, adding a new loading zone on Chestnut Street adjacent to the Playhouse Preschool on Franklin Avenue to accommodate the safe drop off and pickup of students. The subsequent adjustment of existing Township Ordinances allows this change. Loading Zones are permitted for loading or unloading goods, materials and passengers.
