BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey, as follows:

Subsection 7-13 Parking Prohibited at All Times on Certain Streets of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion*, **bold type denotes addition**):

Section 2. Subsection 7-32.2 Restricted Parking Zones of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (italic type denotes deletion, bold type denotes addition):

7-32.2 Restricted Parking Zones. Pursuant to N.J.S.A 39:4-197.6, Restricted Parking Zones, as defined in N.J.S.A. 39:4-207.6e, are established in front of the following residences as indicated on the Tax Maps of the Township of West Orange, at the specified locations. Parking within a specific zone is restricted to the motor vehicle issued a permit pursuant to N.J.S.A. 39:4-197.7. In accordance with N.J.S.A., 39:4-197.6 parking is permitted in the Restricted Parking Zone except when prohibited in front of the residence by other sections of this Chapter.

LEGISLATIVE HISTORY

The Ordinance, which amends the Traffic Regulations of the Township, establishes a

No Parking Zone in front of 14 High Street. The street area in front of this home is too

narrow to park a vehicle safely. Due to the premium on parking spaces in the area, large

vehicles are parking illegally and blocking residential driveways. Additionally, this Ordinance

responds to requests from handicapped residents who reside at 14 Washington Street, 16

Llewellyn Avenue and 77 Kirk Street. By adopting this Ordinance, the Township will establish

handicapped parking stalls adjacent to these addresses. Such parking stalls are permissible

under the laws of New Jersey, and they are designated as Restricted Parking Zones. These stalls

are still subject to other parking regulations and prohibitions on their streets.
