

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC,
SUBSECTION 7-11 PARKING TIME LIMITED ON CERTAIN STREETS DURING CERTAIN
HOURS, AND 7-14.3 PARKING TIME LIMITED ON CERTAIN STREETS DURING CERTAIN
HOURS OF CERTAIN DAYS OF THE REVISED GENERAL ORDINANCES
OF THE TOWNSHIP OF WEST ORANGE**

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey, as follows:

Section 1. Subsection 7-11 Parking Time Limited on Certain Streets During Certain Hours of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

| <u>Name of Street</u> | <u>Side</u> | <u>Time Limit</u> | <u>Hours</u> | <u>Locations</u> |

| <i>Washington Street</i> | <i>North</i> | <i>1 Hour</i> | <i>7AM-7PM</i> | <i>Between Whittlessey Avenue and Watchung Avenue</i> |
| <i>Washington Street</i> | <i>South</i> | <i>1 Hour</i> | <i>7AM-7PM</i> | <i>Between Columbia Street and Watchung Avenue</i> |
| Washington Street | North | 15 Minutes | 8AM-8PM | From 82 feet west of the westerly curb line of Watchung Avenue extended to the easterly curb line of Whittlessey Avenue |
| Washington Street | North | 2 Hours | 8AM-8PM | From the westerly curb line of Whittlessey Avenue to 250 feet west |
| Washington Street | South | 2 Hours | 8AM-8PM | From 306 feet east of the easterly curb line of Main Street extended to the westerly curb line of Watchung Avenue |

Section 2. Subsection 7-14.3 Parking Time Limited on Certain Streets During Certain Hours of Certain Days of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

| <u>Name of Street</u> | <u>Side</u> | <u>Time Limit</u> | <u>Hours</u> | <u>Days</u> | <u>Locations</u> |
|-----------------------|-------------|-------------------|--------------|-------------|--|
| Main Street | East | 15 Minutes | 8AM-8PM | Mon-Sat | From 50 feet north of the northerly curb line of Charles Street extended, and extending 150 feet north. |
| Main Street | East | 2 Hours | 8AM-8PM | Mon-Sat | From 200 feet north of the northerly curb line of Charles Street extended, and extending 320 feet north. |

Section 3. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of the Ordinance are severable.

Section 4. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 5. This Ordinance will take effect upon final passage, publication in accordance with law and the approval of the Essex County Board of Commissioners since Washington Street is a County Road.

LEGISLATIVE HISTORY

The Ordinance, which amends the Traffic Regulations of the Township, amends the Parking Regulations for Washington Street to improve the turnover rate of available parking for businesses on both sides east of Washington School and Fire Station #2. Also, it creates two-hour, and fifteen-minute time limited parking zones on the east side of Main Street, Monday through Saturday, for the convenience of business patrons at the Edison Lofts shopping area. This action is in response to requests for more turnover in the available spaces, which tend to be taken by nearby residents or business owners who park all day. The time limited parking in both areas will be in effect from 8:00 AM to 8:00 PM.
