

ORDINANCE NO. 1185

AN ORDINANCE OF WEST READING BOROUGH, BERKS COUNTY, PENNSYLVANIA AMENDING SECTION 430-24 TITLED "TIME LIMIT PARKING", SECTION 430-26 TITLED "SPECIAL PURPOSE PARKING ZONES", AND SECTION 430-28 TITLED "BUS STOPS; PARKING PROHIBITED" OF ARTICLE III TITLED "PARKING REGULATIONS" OF CHAPTER 430, TITLED "VEHICLES AND TRAFFIC", OF THE BOROUGH OF WEST READING CODE OF ORDINANCES BY: (1) MODIFYING 20-MINUTE PARKING AND 3-HOUR PARKING DESIGNATIONS ALONG THE 300 BLOCK OF SOUTH SEVENTH AVENUE; (2) ADDING 3-HOUR PARKING REGULATIONS TO SOUTH THIRD AVENUE; (3) DESIGNATING 20 MINUTE PARKING SPACES TO THE 400 THROUGH 700 BLOCKS OF PENN AVENUE; (4) ADDING AN ACCESSIBLE PARKING SPACE TO NORTH SIXTH AVENUE; (5) ADDING MULTIPLE ACCESSIBLE PARKING SPACES TO SOUTH SEVENTH AVENUE; (6) ADDING A BUS STOP WITHIN THE 300 BLOCK OF SOUTH SEVENTH AVENUE

BE IT ENACTED AND ORDAINED by the Council of the Borough of West Reading, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. Section 430-24 titled "Time limit parking" of Article III titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances hereby removes the following:

Section 2. Section 430-24 titled "Time limit parking" of Article III titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances is hereby supplemented by adding thereto the following:

Section 3. Section 430-26 titled "Special purpose parking zones" of Article III titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances hereby removes the following:

South Seventh Avenue	East	Handicapped person	Every day	From a point 577 feet south of the curblin on the south side of Spruce Street to a point 45 feet southwardly thereof

Section 4. Section 430-26 titled "Special purpose parking zones" of Article III titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances is hereby supplemented by adding thereto the following:

Name of Street	Side	Authorized Purpose	Days	Location
North Sixth Avenue	West	Handicapped person	Every day	Second space north of Court Street
South Seventh Avenue	East	Handicapped person	Every day	From a point 322 feet south of the curblin on the south side of Spruce Street to a point 191 feet southwardly thereof (9 spaces); from a point 574 feet south of the curblin on the south side of Spruce Street to a point 23 feet southwardly thereof (1 space)

Section 5. Section 430,"8 titled "Bus stops; parking prohibited" of Article III titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances hereby removes the following:

Name of Street	Side	Location
South Seventh Avenue	East	A point 60 feet south of the curblin of the south side of Spruce Street and a point 55 feet southwardly

Section 6. Section 430-28 titled "Bus stops; parking prohibited" of Article III titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances is hereby supplemented by adding thereto the following:

Name of Street	Side	Location
South Seventh Avenue	East	A point 60 feet south of the curblin of the south side of Spruce Street and a point 55 feet southwardly thereof; a point 866 feet south of the curblin on the south side of Spruce Street and a point 76 feet southwardly thereof

Section 7. All Ordinances or Parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

Section 8. This Ordinance shall become effective upon enactment.

Section 9. The Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, upon adoption.


