

ORDINANCE NO. 1201

AN ORDINANCE OF THE BOROUGH OF WEST READING, BERKS COUNTY, PENNSYLVANIA, AMENDING SUBSECTION B, TITLED "STANDARD METER RATES" OF SECTION 363-10, TITLED "CHARGES FOR DOMESTIC SEWAGE", OF ARTICLE II, TITLED "SEWER RENTALS", OF CHAPTER 363, TITLED "SEWERS AND SEWAGE DISPOSAL", OF THE BOROUGH OF WEST READING CODE OF ORDINANCES BY AMENDING THE STANDARD METER RATES.

BE IT ENACTED by the Borough Council of the Borough of West Reading, Berks County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. Subsection B, titled "Standard meter rates", of Section 363-10, titled "Charges for domestic sewage", of Article II, titled "Sewer Rentals", of Chapter 363, titled "Sewers and Sewage Disposal", of the Borough of West Reading Code of Ordinances is hereby amended in its entirety to read hereafter as follows:

B. Standard meter rates. The following rates will apply to all quantities discharged, based upon water usage:

(1) Quarterly rates.

(a) The first 900 cubic feet or less, per quarter, per unit: \$ 38.21.

(b) Over 900 cubic feet: \$4.26 per 100 cubic feet.

(2) Monthly rates.

(a) The first 300 cubic feet or less, per month, per unit: \$14.82.

(b) Over 300 cubic feet: \$4.94 per 100 cubic feet.

Section 2. All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.


Section 3. This Ordinance shall become effective upon enactment, and the increased sewer rates and charges for sewer service shall apply to all water consumers on or after January 1, 2026.

Section 4. The Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, upon adoption.


