

ORDINANCE NO. 1206

AN ORDINANCE OF WEST READING BOROUGH, BERKS COUNTY, PENNSYLVANIA AMENDING CHAPTER 430, TITLED "VEHICLES AND TRAFFIC, OF ARTICLE III, TITLED "PARKING REGULATIONS" OF SECTION 430-24, TITLED "TIME LIMIT PARKING" TO REMOVE CONFLICTING NORTH FIFTH AVENUE REGULATIONS; SECTION 430-26, TITLED "SPECIAL PURPOSE PARKING ZONES" TO ADD AND REMOVE HANDICAPPED PERSON PARKING SPACES ON CHESTNUT STREET, FRANKLIN STREET, SOUTH FIFTH AVENUE, SOUTH FOURTH AVENUE, SUMMIT STREET AND TULPEHOCKEN AVENUE.

BE IT ENACTED AND ORDAINED by the Council of the Borough of West Reading, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. Section 430-24 "Time limit parking" of Article III titled "Parking Regulations", of Chapter 430 titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances, to remove the following location:

Name of Street	Side	Time Limit	Hours	Days	Location
Fifth Avenue	East	20 minutes	At all times	Everyday	Between Penn Avenue and Court Street

Section 2. Section 430-26 "Special purpose parking zones" of Article III titled "Parking Regulations", of Chapter 430 titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances, to add or remove the following locations:

Name of Street	Side	Authorized Purpose	Days	Location
Chestnut Street	North	Handicapped person	Every day	Tenth space west of South Fourth Avenue
Chestnut Street	South	Handicapped person	Every day	Fifth space west of South Third Avenue
Franklin Street	North	Handicapped person	Every day	Sixth space east of South Seventh Avenue
Franklin Street	South	Handicapped person	Every day	Fifth space east of South Fifth Avenue
South Fourth Avenue	East	Handicapped person	Every day	First space south of Chestnut Street
Summit Street	East	Handicapped person	Every day	First space at the southeast corner of North Third Avenue and Summit Street

Section 3. All Ordinances or Parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

Section 4. This Ordinance shall become effective upon enactment.

Section 5. The Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the

Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, upon adoption.
