ORDINANCE NO. 04-2024

**AN ORDINANCE OF THE TOWNSHIP OF WEST MANHEIM, YORK COUNTY, PENNSYLVANIA, AMENDING SECTION 179-8, ENTITLED "REGULATIONS," OF CHAPTER 179, ENTITLED "PEDDLING AND SOLICITING," BY THE DELETION OF SUBSECTION (F) THEREOF.**

**WHEREAS**, the Board of Supervisors of West Manheim Township, York County, Pennsylvania, adopted Ordinance 1-2015 on April 2, 2015, to provide standards defining and regulating peddling and soliciting within West Manheim Township; and

**WHEREAS**, the above-referenced Ordinance was codified as Chapter 179 of the Code of Ordinances of West Manheim Township; and

**WHEREAS**, the Board of Supervisors of West Manheim Township, York County, Pennsylvania desire to amend Chapter 179 of the Code of Ordinances of West Manheim Township to delete Section 179-8(F) in order to permit peddling and soliciting within a street or right-of-way in order to allow such things as ice cream trucks, sno-ball trucks and other food trucks to obtain a license to operate on the streets and within the rights-of-way with the Township in the interests of the health, safety and general welfare of the residents of West Manheim Township.

**NOW, THEREFORE, BE IT SO ENACTED AND ORDAINED**, by the Board of Supervisors of West Manheim Township, York County, Pennsylvania, by the authority of the same, as follows:

Section 1. Section 179-8 of Chapter 179 of the Code of Ordinances of West Manheim Township is hereby amended by the deletion of Subsection 179-8(F), in its entirety, which reads as follows:

~~"F.— No peddling or soliciting, or any other activities, whether or not a license is required, shall occur within any street or right-of-way."~~

Section 2. Procedural Defects in Enactment.

Allegations that this Ordinance or any amendment was enacted in a procedurally defective manner shall be appealed as provided in Pennsylvania law.

Section 3. Enactment.

This Ordinance shall become effective in 5 calendar days, as provided by law.




