

**ORDINANCE NO. 25-1535**

**ORDINANCE AMENDING SECTION 1 & 2 OF ARTICLE 16 OF CHAPTER 11 OF THE WESTVILLE VILLAGE CODE (HOLIDAYS)**

WHEREAS, the corporate authorities of the Village of Westville pursuant to the powers granted to it under 65 ILCS 5/3.1-40-25, 5 ILCS Sec. 120/2.02, and 5 ILCS Sec. 120/2.04; and

WHEREAS, the Village heretofore has adopted Section 1, of Article 16 of Chapter 11, of the Westville Village Code to establish holidays for the Village employees; and

WHEREAS, the Village has determined that it is in the best interest, health, and welfare of the Village and its residents to amend Section 1 of Article 16 of Chapter 11.

NOW, THEREFORE, BE IT ORDAINED by the Village Trustees of the Village of Westville, Illinois as follows:

**Section 1.** The recitals hereinabove set forth are hereby incorporated by reference.

**Section 2.** Amendments:

11-16-1 of the Westville Village Code is hereby amended to read as follows: **PAID HOLIDAYS ESTABLISHED.** All full-time employees except full-time employees of the Westville Police Department shall be entitled to the following holidays with pay:

Employee Individual Birthday	Memorial Day	Thanksgiving Day
New Year's Day	Independence Day	Day after Thanksgiving
Martin Luther King Jr. Birthday	Labor Day	Christmas Eve Day
President's Day	Columbus Day	Christmas Day
Spring Holiday	Veteran's Day	New Year's Eve Day

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**Section 4.** All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 5.** If any part of this Ordinance is found to be in conflict with any other Ordinance, Resolution, motion or order or parts thereof, the most restrictive or highest standard shall prevail.

**Section 6.** This Ordinance shall be in full force and effect beginning January 2026 and after its passage, approval and publication as provided by law.






