ORDINANCE NO. 23-03

AN ORDINANCE OF THE TOWN OF WESTOVER HILLS, TEXAS AMENDING THE CODE OF ORDINANCES OF THE TOWN OF WESTOVER HILLS BY AMENDING SEC. 12.02.007(a) STOP AND YIELD SIGNS; REPEALING CONFLICTING ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Westover Hills, Texas (the "Town"), is a is a general law municipality and is authorized to enact regulations as necessary to protect the health, safety and welfare of the public and, may enact ordinances relative to its citizens' health, safety, and welfare that are not inconsistent with the Constitution and laws of the State;; and

WHEREAS, Section 311.002 of the Texas Transportation Code provides that a generallaw municipality has exclusive control over and under the public highways, streets, and alleys of the municipality; and

WHEREAS, the Texas Transportation Code, Section 542.202(a)(8) Powers of Local Authorities, grants the Town the authority to designate an intersection as a stop intersection and requiring each vehicle to stop at one or more entrances to the intersection; and

WHEREAS, all statutory and constitutional requirements for the passage of this ordinance have been adhered to, including but not limited to the Open Meetings Act; and

WHEREAS, the purpose of this ordinance is to promote the public health, safety, and general welfare of the citizens of the Town of Westover Hills;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Westover Hills, Texas:

<u>SECTION 1.</u> That, the statements contained in the preamble to this ordinance are hereby adopted as findings of fact and as a part of the operative provisions hereof.

SECTION 2. That, the Code of Ordinances of the Town of Westover Hills subsection (a) of SECTION 12.02.007 STOP AND YIELD SIGNS, is hereby amended and replaced with the following:

(a) Stop and yield signs shall be erected at the following intersections, and such intersections are hereby designated as follows:

<u>SECTION 5</u>. That, should any sentence, paragraph, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole, or any part or provision thereof other than the part thereof decided to be unconstitutional, illegal, or invalid, and the same shall not affect the validity of the Code of Ordinances of the Town of Westover Hills as a whole.

SECTION 6. That, this ordinance shall take effect immediately following its passage, approval, and publication as provided by law, and it is accordingly so ordained.
