ORDINANCE NO. 422

AN ORDINANCE AMENDING THE TOWNSHIP'S CODE OF ORDINANCES AT CHAPTER 142 [VEHICLES AND TRAFFIC] ARTICLE II [TRAFFIC REGULATIONS] SECTION 142-17 [RIGHT TURNS ONLY PERMITTED AT CERTAIN INTERSECTIONS] TO ESTABLISH RIGHT TURNS ONLY FROM SYMPHONY LANE AT SKIPPACK PIKE DURING CERTAIN HOURS

WHEREAS, The Board of Supervisors of Whitpain Township is duly empowered by the Second Class Township Code, 53 P.S. § 65101, *et seq.*, to enact certain regulations relating to the public health, safety and welfare of the residents of Whitpain Township; and

WHEREAS, the Second Class Township Code authorizes the Board of Supervisors to make, amend and adopt amendments to the Whitpain Code of Ordinances, as amended, that are consistent with the Constitution and laws of the Commonwealth that it deems necessary for the proper management and control of the Township and the best interests of its residents;

WHEREAS, the Board of Supervisors of Whitpain Township has determined that certain amendments to the Whitpain Township Code of Ordinances, as amended, are required for the orderly administration of the laws of Whitpain Township; and

WHEREAS, the Code of Ordinances Chapter 142, Article II, Section 142-17 prescribes right turns only from certain streets within the Township; and

WHEREAS, upon careful review, the Board of Supervisors has determined that a restriction on all other movements except for right turns from Symphony Lane onto Skippack Pike (right turns only) is necessary for the maintenance of peace, good government, health and welfare of the Township and its residents.

NOW, THEREFORE, BE IT HEREBY ORDAINED AND ENACTED by the Board of Supervisors of Whitpain Township, as follows:

SECTION 1. Amendment to Chapter 142 [Vehicles and Traffic] Article II [Traffic Regulations] Section 142-17 [Right Turns Only Permitted at Certain Intersections].

The Township's Code Chapter 142 (Vehicles and Traffic) Article II (Traffic Regulations) Section 142-17 (Right Turns Only Permitted at Certain Intersections) shall be amended to establish a right-turns only permitted turning restriction from Symphony Lane onto Skippack Pike during certain hours and shall read, in pertinent part, as follows:

§142-7 Right turns only permitted at certain intersections.

A. It shall be unlawful for the driver of any vehicle traveling upon the first-named street at any of the following intersections, in the direction or directions indicated in each case, to make other than a right turn at any time stated, both left turns and straight-across traffic being prohibited:

Vehicle Traveling on	Direction of Travel	Times	Not to Make Left Turn or Travel Straight Across
Symphony Lane	Southbound	Monday-Friday 8:00 a.m. to 9:00 a.m. 3:00 p.m. to 4:00 p.m.	Skippack Pike

SECTION 2. Repeal and Ratification.

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION 3. Severability.

Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and affect, and for this reason the provisions of this Ordinance shall be severable.

SECTION 4. Effective Date.

This Ordinance shall become effective five (5) days after enactment.
