

TOWNSHIP OF WINSLOW, NEW JERSEY, CAMDEN COUNTY

**AN ORDINANCE OF THE TOWNSHIP OF WINSLOW,
COUNTY OF CAMDEN, NEW JERSEY, RE-
APPROPRIATING \$1,660,773 FROM THE UTILITY
CAPITAL FUND TO THE GENERAL CAPITAL FUND FOR
STORM WATER AND DRAINAGE REMEDIATION
IMPROVEMENTS IN AND FOR THE TOWNSHIP**

WHEREAS, the Township of Winslow, County of Camden, New Jersey ("Township") has heretofore duly and finally adopted Ordinances Nos. 21-21 and 14-22 (collectively, the "Prior Ordinances") to fund certain water and sewer utility improvements including, but not limited to, the acquisition and installation of a new well filtration system (Well 2) and various water and sewer infrastructure projects (collectively, the "Prior Improvements"); and

WHEREAS, the Township has completed, or will in the immediate future complete, the Prior Improvements and has determined that there are remaining unspent funds under each of the Prior Ordinances in the aggregate amount of \$1,660,773 not required for the payment of any of the costs of such Prior Improvements (referred to herein as the "Remaining Funds"); and

WHEREAS, as a result thereof, the Township is now desirous of re-appropriating such Remaining Funds for the completion of various storm water and drainage remediation improvements as hereinafter described.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINSLOW, COUNTY OF CAMDEN, STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. There is hereby re-appropriated the sum of \$1,660,773 from the Utility Capital Fund to the General Capital Fund for the completion of various storm water and drainage remediation improvements in and for the Township including, but not limited to, storm water and drainage remediation improvements for Beebetown Road, together with the acquisition of all materials and equipment and completion of all work necessary therefore or related thereto (collectively, the "Project"). The funds hereby re-appropriated for the Project have been made available from an allocation of funds to the Township from the Federal government pursuant to the American Rescue Plan Act of 2021 and specifically, the Coronavirus Local Fiscal Recovery Fund.

Section 2. It is hereby determined and stated that the Project set forth in Section 1 is a capital improvement and is not a current expense of the Township.

Section 3. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the

Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.


Section 4. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.
