ORDINANCE 2024 - 08 **ORDINANCE** OF THE **TOWNSHIP OF** WILLINGBORO, IN THE COUNTY OF BURLINGTON, **PROVIDING** THE RE-NEW **JERSEY** FOR APPROPRIATION **OF** \$80,603.01, \$78,103.01 **OF** PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES AND \$2,500 FROM THE CAPITAL IMPROVEMENT FUND, IN ORDER TO AND **PROVIDE FOR** THE RENOVATION BUILDINGS. **IMPPOVEMENTS** TO MUNICIPAL PARKS AND ROADWAYS

Be it Ordained by the Township Council in the Township of Willingboro, in the County of Burlington, State of New Jersey with not less than two-thirds of all members thereof affirmatively concurring as follows:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$78,103.01 of the proceed of obligations made available pursuant to the following sections of the bond ordinance referenced below of the Township of Willingboro, in the County of Burlington, New Jersey (the "Township") are no longer necessary for the various purposes for which the obligations were authorized. The down payment appropriated for the purpose in Section 3(a)(i) below in the amount of \$2,500 is also no longer necessary for the acquisition of a street sweeper.

Section 2. The \$80,603.01, consisting of the \$78,103.01 proceeds described in Section 1 hereof and made available pursuant to N.J.S.A. 40A:2-39 and the \$2,500 from the Capital Improvement Fund, are hereby re-appropriated to provide for the renovation and improvements to municipal buildings, parks and roadways, including all work and materials necessary therefor and Page 1 of 2

incidental thereto.

Section 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
