**ORDINANCE 2024 - 07**

**ORDINANCE OF THE TOWNSHIP OF WILLINGBORO, IN  
THE COUNTY OF BURLINGTON, NEW JERSEY PROVIDING  
FOR THE RE-APPROPRIATION OF \$125,000.00 IN UNUSED  
DEBT AUTHORIZATIONS NOT NEEDED FOR THEIR  
ORIGINAL PURPOSES IN ORDER TO PROVIDE FOR  
STORMWATER PROJECT FOR CHARLESTON RD  
CULVERT**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than Two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that certain debt authorizations in the aggregate amount of \$125,000.00 provided for in the various ordinances listed below are no longer needed for the purposes referenced therein. The Township of Willingboro, in the County of Burlington, New Jersey (the "Township") desires, therefore, to re-appropriate the following debt authorizations:

Section 2. The aggregate amount of \$125,000.00 described in Section 1 hereof and made available pursuant to N.J.S.A. 40A:2-39 hereby re-appropriated to provide for the following:




Section 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
