

ORDINANCE 2023 – 20

ORDINANCE AMENDING SECTION 1 OF BOND ORDINANCE #2022-6 OF THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY, FINALLY ADOPTED JUNE 21, 2022, IN ORDER TO AMEND THE DESCRIPTION OF THE PROJECT TO INCLUDE BABBITT LANE.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Section 1 of Bond Ordinance #2022-6 of the Township of Willingboro, in the County of Burlington, New Jersey (the "Township"), finally adopted June 21, 2022, is hereby amended in its entirety to read as follows:

"\$865,200 is hereby appropriated from American Rescue Plan Act funds for stormwater infrastructure repairs, including Buckingham Drive, Berkshire Lane, 115 Clubhouse Drive, Clubhouse Drive, Babbitt Lane and Windsor Lane and the Holston Lane outfall, including all work and materials necessary therefor and incidental thereto, in and by the Township of Willingboro, in the County of Burlington, New Jersey (the "Township")."

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.


Section 3. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
